

MISS QUINCY CONTRACT ADDENDUM

I, _____, understand while holding the title of Miss Quincy, there are rules I must follow. I understand failure to follow the rules reflects negatively upon me and upon the Miss Quincy Scholarship Program. I understand failure to follow the rules will result in a conference with the Miss Quincy Scholarship Program Executive Director, and can be grounds upon which I may be asked to relinquish my title. Therefore, I understand the following policy is in place.

As Miss Quincy 2018:

1. I will not smoke or drink alcoholic beverages while wearing my crown, sash or any other item that designates me as a titleholder, or while being present at any appearance.
2. Any and all tattoos, body piercings, etc. will be covered at all times while wearing my crown or sash or any other item that designates me as a titleholder or while being present at any appearance.
3. I will refrain from the use of foul language and other lewd or offensive conduct while wearing my crown or sash or any other item that designates me as a titleholder or while being present at any appearance.
4. I will arrive at least fifteen minutes prior to the start time of any appearance or Miss Quincy Scholarship Program event.
5. I will always look my best while representing the Miss Quincy Scholarship Program by dressing appropriately for the event and keeping my hair, makeup and nails well-kept.
6. I understand boyfriends are not allowed at appearances without special permission from the Miss Quincy Scholarship Program Executive Director.
7. I understand all appearances must be approved through the Miss Quincy Scholarship Program Executive Director.
8. I understand the use of social media, such as Facebook and Twitter, is encouraged. However, I will be mindful of the information I post. Online behavior should reflect the same standards as those used for face-to-face communication. I will view social media as an extension of the Miss Quincy Scholarship Program. I ensure the content I post reflects the standards and expectations of a Miss America Organization Titleholder.
9. I will not consult with a pageant coach or talent consultant without the permission of the Miss Quincy Scholarship Program Executive Director.
10. I will reply to all e-mails from the Miss Quincy Scholarship Program and the Miss Illinois Scholarship Association with at least "received."
11. I understand once I commit to an appearance, I'm expected to attend except in the case of an emergency.
12. I will treat the Miss Quincy Executive Director, Board of Directors and volunteers with the utmost courtesy and respect.

13. I will promptly return all phone calls, e-mails and text messages from the Miss Quincy Scholarship Program Executive Director, members of the board and sponsors.
14. I understand as the ambassador for the city of Quincy, and representative of the Miss Quincy Scholarship Program, I am expected to make at least two appearances each month, but more are encouraged.
15. I will not partake in any media interviews regarding the Miss Quincy Scholarship Program without permission from the Executive Director.
16. I will promptly follow all appearances with a thank you note to the organizer.
17. I will promptly send thank you notes for all prizes and scholarship awards I receive. I understand it is common courtesy to provide a tip for any sponsored services such as haircuts, spray tans, manicures, etc.
18. I understand I am expected to promote and show gratitude to sponsors via social media.
19. I will not serve as a volunteer for any other pageant without special permission from the Miss Quincy Scholarship Program Executive Director. I will not recruit contestants for any pageant system other than the Miss America Organization.
20. I will not make any unfavorable statements, oral or written, which is detrimental to the reputation or goodwill of the Miss Quincy Scholarship Program, its directors, or volunteers.
